- The priority given to fire trucks moving through Coquitlam intersections during emergencies
- Details regarding the one-year trial of 511 software
- Traffic challenges at the Westwood Street rail crossing and how 511 software would provide public notification of train crossings
- The technologies that could be utilized in the future by railway lines so that crossing wait times could be shared with the public in real time

The Committee considered the following focus questions:

- Do you have any suggestions regarding how we can reduce barriers to participation and be as inclusive as possible during this process?
- Are there any equity or inclusivity issues you see with respect to the current
- transportation network in Coquitlam?

Discussion ensued relative to the following:

- The belief that poor drivers are one of the main safety-related barriers to more people choosing to cycle in Coquitlam
- The understanding that cyclists will often plan their routes based upon which ones they consider to be the safest, rather than the most direct (fastest) or convenient
- The belief that connected routes like MUPs allow pedestrians and cyclists to feel safer because they can travel through the city without having to worry about vehicle traffic
- The observation that although pedestrians and cyclists prefer to use MUPs, it is not always possible due to gaps between pathways
- The belief that, during the pandemic, over-crowded bus stops and disorderly entry/exit on and off of buses was one of the main safety-related barriers to youth taking transit in Coquitlam
- The belief that more pedestrian activated walk signals at intersections would be a helpful way to ensure that youth feel safer walking in Coquitlam
- The suggestion that staff engage youth at transit hubs and bus stops proximal to local schools where students regularly commute
- Whether the City planned to conduct an engagement survey
- The desire that staff consider ways to provide marginalized people with an opportunity to give input to the planned survey or other engagements

The Major Project Planner provided his contact information to the Committee members and the Chair encouraged the Committee to email any further input to staff.

The Staff Sergeant introduced himself and provided a presentation, utilizing on-screen slides titled as follows:

Discussion ensued relative to the following:

- The belief that the traffic enforcement technologies utilized in the City, including "Black Cats" and red light cameras installed in intersections around the city, were excellent
- Whether ICBC shared the data captured by red light cameras with the RCMP
- Whether the installation of red light cameras was having a positive impact in the city,
   i.e. reducing the number of traffic violations occurring in intersections
