

## PART 8 AGRICULTURAL AND RESOURCE ZONES

### 801 A-3 Agricultural and Resource

#### (1) Intent

This zone provides for agricultural and resource *uses* as well as limited *residential uses* on large acreage lots. Provision is made for the keeping of animals.

#### (2) Permitted Uses

The following *uses* and no others are permitted in this zone:

*Principal uses:*

- (a) *Agricultural*;
- (b) *Resource*, as limited to Sub-section (3)(b);
- (c) *One-family residential*;
- (d) *Boarding*, as limited to Sub-section (3)(a) and (3)(e);
- (e) *Industrial*, limited to stone and concrete products, and as further limited under Sub-section (3)(f), (3)(g) and (3)(h);
- (f) *Public Service*.

*Accessory uses:*

- (a) *Accessory office*, as limited under Sub-section (3)(f);
- (b) *Accessory residential*, as limited in Sub-section (3)(e);
- (c) *Accessory employee residential*, as limited in Sub-section (3)(c) and (3)(e);
- (d) *Accessory produce sales*, as limited in Sub-section (3)(d).

#### (2) (a) Additional Permitted Uses

The following *uses* and no others are permitted in this zone:

*Principal uses:*

- (a) *Industrial*, limited to:
  - (i) batch plants for concrete and asphalt; and
  - (ii) manufacture of cast concrete products;and as further limited under Section (3A).

*Accessory uses:*

- (a) *Accessory office*, as limited under Section (3A);
- (b) Accessory washing, servicing and repair of motor vehicles associated with the business conducting a permitted industrial use as limited by Section (2A)(a), at the locations specified in Section (3A);
- (c) *Accessory retail*, limited to the retail sale of asphalt and concrete or related products, as limited under Section (3A).

**(3) Conditions of Use**

- (a) A *boarding use* is not permitted except in conjunction with a *one-family residential use* and must not accommodate more than four boarders.
- (b) A *resource use* involving the storage of motor vehicles and equipment is permitted only on a *lot*:
  - (i) occupied by a *resource use*;
  - (ii) abutting a *lot* occupied by a *resource use*; or
  - (iii) formerly occupied by a *resource use*.
- (c) No more than one *dwelling unit* for *accessory caretaker use* is permitted per *lot*.
- (d) The *floor area* used for *accessory produce sales use* must not exceed 12 m<sup>2</sup>.
- (e) The following *uses* are not permitted on a *lot* having an area less than 8.1 hectares:
  - (i) *boarding*;
  - (ii) *accessory residential*;
  - (iii) *accessory caretaker*.
- (f) *Industrial*, limited to stone and concrete products and *accessory office* permitted only at the following location:

- (g) All stationary equipment associated with a permitted *industrial use* must be enclosed within a *building* except for stone splitting and material heating equipment;
- (h) An *industrial use* is only permitted if there is a *Resource Use* on the same *lot*.

**(3A) Additional Conditions of Use**

- (a) *Industrial*, limited to batch plants for concrete and asphalt, and manufacture of cast concrete products, *accessory office* and *accessory retail* are permitted only at the following locations:

- (b) Conditions of Use in Section 3 applicable to *industrial use* do not apply to the locations listed in this Section (3A).

**(4) Lot Size**

- (a) The minimum *lot size* is 8.1 hectares.
- (b) Notwithstanding (a), the minimum *lot size* for an *industrial use*, as limited by Section (2A) at the locations specified in Section (3A), is 2,000 m<sup>2</sup>.
- (c) Notwithstanding (a), the minimum *lot size* is not applicable for a *Public service use*.

**(5) Density**

Not applicable in this zone.

**(6) Lot Coverage**

- (a) All *buildings* and *structures* together must not exceed a *lot coverage* of 30%.
- (b) In addition to (a), *buildings* and *structures* for the specific *uses* set out below must not exceed the corresponding *lot coverages* set out below:

**(7) Buildings Per Lot**

For each of the *uses* set out below, no more than one *building* or *structure* for that *use* is permitted per *lot*:

- (a) *One-family residential*
- (b) *Accessory caretaker*
- (c) *Accessory produce sales*

**(8) Setbacks**

(a) *Buildings* and *structures* for the following *uses* must be sited no closer than the corresponding setbacks from *lot* lines, bodies of water and other *uses* as set out below:

(b) The above setbacks are subject to increase under section 518, 519 and 523 of this Bylaw.

**(9) Location of Uses**

Not applicable in this zone.

**(10) Height**

*Buildings and structures* for the *uses* set out below must not exceed the *heights* set out below:

<i>Accessory Produce Sales</i>	11

**(11) Building Size**

Not applicable in this zone.

**(12) Off-Street Parking and Loading**

The regulations under Part 7 apply.

**(13) Other Regulations**

(a) For properties located in the Agricultural Land Reserve, the regulations under the Agricultural Land Commission Act and the Agricultural Land Reserve Use Regulation apply.

(b) The regulations under Part 2, Part 3, Part 4, Part 5 and Part 6 apply.
