I. **REVISE:** Existing sanitary pipework from concession revised to better reflect on-site conditions.

II. **ADD:** Existing hose bib and sanitary venting added to drawing.

III. **REVISE:** Existing domestic, storm, condensate, and sanitary venting pipework from Concession revised to better reflect on-site conditions.

R2) REPLACE

In Appendix F Section 11.1.2 where it states:

All insurance policies required under this *Contract* must:

(a) name the Owner and School District #43 Coquitlam as an additional insured;

Is Replaced with:

(a) name the Owner and City of Coquitlam as an additional insured;

QUESTIONS AND CLARIFICATIONS

- Q1) How thick is existing suspended concrete slab?
- A1) Suspended floor slab is 225 mm thick at Concession.
- Q2) Is it correct that there is no sprinkler work required for this project?
- A2) Sprinklers are not required in the concession. All penetrations through concession walls and floor will require fire stopping.
- Q3) The plumbing work shown on the RFP mechanical drawings does not match the site conditions installed by Graham. Please advise.
- A3) See R1 above.
- Q4) The ceiling work clarification. There is no ceiling installed on site, yet it looks the RFP drawings anticipate the ceiling being installed by Graham. Please confirm. Please clarify how fire stopping to be dealt with.
- A4) Ceiling will be installed as part of the base building before construction start. As part of the Scope of Work existing ceiling to be cut back to facilitate fire stopping at top of wall and roof slab per A2.03 Sections. Ceiling to be patched and repaired per A2.01 Ceiling Type.
