

Notice is hereby given that the City of Coquitlam will be holding a Public Hearing on **Monday, May 12, 2025**, at 7:00 p.m. at City Hall Council Chambers, 3000 Guildford Way, Coquitlam, BC V3B 7N2 to receive representations from all persons who deem it in their interest to address Council regarding the following proposed bylaws.

The intent of **Bylaw No. 5407, 2025** is to enter into a Heritage Revitalization Agreement (HRA) to restore and relocate the Heritage Home known as the Chine Residence in order to allow for subdivision of the property located at 910 Westwood Street into a total of three parcels, each with a single family home and a carriage house.

The intent of **Bylaw No. 5408, 2025** is to formally designate the Chine Residence as having heritage value in order to protect the heritage property and prohibit any unauthorized alterations.

If approved, the application would designate the heritage property and permit the restoration and relocation of the Chine Residence, as well as the construction of two new single family homes and three new carriage homes.
