Q4. Please confirm whether quantity is 2 goals in total or 2 sets of goals. Goals come in a set of 2 but quantity in the document does not specify units or sets.

A4. Please include 2 goals / 1 set of goals as indicated on Drawing LD-04 for soccer, field hockey and lacrosse.
