

## Notice of Zoning Amendment Bylaw for First, Second and Third Readings – 831 Edgar Avenue – Bylaw No. 5431, 2025

Notice is hereby given that the City of Coquitlam has received an application to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* relating to the properties located at 831 Edgar Avenue. Please note that this application was previously considered by Council at the March 31, 2025 Regular Council Meeting and was referred back to staff for revisions. The application has now been revised by reducing the number of units from nine to eight.

The amending Bylaw (No. 5431, 2025) will be presented for first, second and third readings at the Regular Council Meeting on **Monday, July 7, 2025** at 7:00 p.m. in the Council Chambers of City Hall, located at 3000 Guildford Way, Coquitlam, BC.

The intent of Bylaw No. 5431, 2025 is to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* to rezone a portion of the subject property as outlined in black on the map marked "Schedule 'A' to Bylaw 5431, 2025" from R-1 Small-Scale Residential to R-4 Intensive Small-Scale Residential.



If approved, the application would facilitate the development of eight multi-residential units within three buildings, consisting of 3-bedroom unit types.
